3.2 The petitioner preferred appeal under Section 53(1) of the Act before the Chief Controlling Revenue Authority which culminated into the impugned order.

4. Heard learned senior advocate Mr. Shalin Mehta assisted by learned advocate Mr. Girish Patel for the petitioner and learned Assistant Government Pleader Ms. Snusha Joshi for the respondent state authorities.

4.1 The respondent authorities took a view that the document in question was liable to be treated as deed of exchange as it involved the exchange of property, and the same was not a sale and was not in the nature of sale deed and that the same was not a Conveyance, therefore, the benefit of reduced rate of stamp duty as provided in the Revenue Department's Order dated 29th October, 1992 would not be available to the petitioner trust.

4.2 The stamp duty on Conveyance is charged under Article 20 to Schedule-I to the Stamp Act, 1958. Article 20 prescribes stamp duty for various classes of Conveyances mentioned in the Article in its sub-clauses. As far as the instrument of exchange of property is concerned, the stamp duty charged under Article 26 to Schedule-I of the Act. It provides that

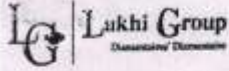
